WWW.HALALBEATS.IO (“**our website**”) is operated by Fleek Media Ltd, registered in England and Wales with company number 09563384, whose registered office is at 85 Great Portland Street, First Floor, London, W1W 7LT, trading as **Halal Beats** (“**we**”, “**us**”, “**our**”).

Halal Beats respects your privacy and is committed to protecting your Personal Data. This Privacy Policy will inform you as to how we look after your Personal Data when you visit our website (regardless of where you visit it from), and tell you about your privacy rights and how the law protects you.

### 1. INTRODUCTION



- 1.1. It is important that you read this Privacy Policy together with any other privacy policy or any fair processing policy that Halal Beats may provide on specific occasions when collecting, or processing, Personal Data about you, so that you are fully aware of how, and why, we are using your data. This Privacy Policy supplements other notices and policies, and is not intended to override them.
- 1.2. We keep our Privacy Policy under regular review. This version was last updated on the 1st November 2020.

## 2. CONTROLLER

- 2.1. Halal Beats is the controller and is responsible for your Personal Data.
- 2.2. We have appointed a data protection officer (DPO) who is responsible for overseeing questions in relation to this Privacy Policy. If you have any questions about this Privacy Policy of our privacy practices, including any requests to exercise your legal rights, please contact the DPO using the details set out below:

- 2.3. It is important that the Personal Data we hold about you is accurate and current. Please keep Halal Beats informed if your Personal Data changes during your relationship with us.
- 2.4. You have the right to make a complaint at any time, to the Information Commissioner's Office (ICO), the UK supervisory authority for data protection issues ([www.ico.org.uk](http://www.ico.org.uk)). We would, however, appreciate the chance to deal with your concerns before you approach the ICO, so please contact us in the first instance. In the event that you need to contact the ICO, our ICO number is ZA779915.

## 3. THE DATA WE COLLECT ABOUT YOU

- 3.1. Halal Beats may process your Personal Data without your knowledge or consent, where this is required or permitted by law.
- 3.2. **We may collect, use, store, and transfer different kinds of Personal Data about you which we have grouped together as follows:**



- 3.2.1. **Identity Data** includes first name, maiden name, last name, username, or similar identifier; marital status, title, date of birth, and gender. You can always refuse to offer any information, but it may prevent you from using some aspects of the site.
- 3.2.2. **Contact Data** may include billing address, delivery address, email address, and telephone numbers. You can always refuse to offer any information, but it may prevent you from using some aspects of the site.
- 3.2.3. **Financial Data** includes bank account and payment card details.
- 3.2.4. **Transaction Data** includes details about payments to, and from, you; and other details of products and services you have purchased from us.
- 3.2.5. **Technical Data** includes internet protocol (IP) address, your login data, browser type and version, time zone setting and location, browser plug-in types and versions, operating system and platform, and other technology on the devices you use to access our website. This information is collected using cookies. It helps Halal Beats to provide quality standards in website browsing and also to indicate where the website requires improvements.
- 3.2.6. **Profile Data** includes your username, password, purchases, and orders made by you, and your interests, preferences, feedback, and survey responses.
- 3.2.7. **Usage Data** includes information about how you use our website, products, and services. For customers, Information about your subscriptions, other purchases and payment made.
- 3.2.8. **Marketing and Communications Data** includes your preferences in receiving marketing from Halal Beats and our third parties, and your communication preferences. You can opt out from receiving marketing messages by clicking the unsubscribe link in any email from Halal Beats.
- 3.2.9. We also collect, use, and share **Aggregated Data**, such as statistical or Demographic Data for any purpose. Aggregated Data could be derived from your Personal Data but is not considered *Personal Data* in law, as this data will not directly or indirectly reveal your identity. For example, we may aggregate your Usage Data to calculate the percentage of users accessing a specific website feature. However, if we combine or connect Aggregated Data with your Personal Data so that it can directly or indirectly identify you, we treat the combined data



as Personal Data, which will be used in accordance with this Privacy Policy.

- 3.3. We **do not** collect any **Special Categories of Personal Data** about you. This includes details about your race or ethnicity, religious or philosophical beliefs, sex life, sexual orientation, political opinions, trade union membership, health, and genetic and biometric data. Nor do we collect any information about criminal convictions and offences.
- 3.4. WWW.HALALBEATS.IO is not intended for children and we **do not** knowingly collect data relating to children.

#### 4. HOW YOUR PERSONAL DATA IS COLLECTED

##### 4.1. Halal Beats use different methods to collect data from, and about, you:

4.1.1. **Direct interactions.** You may give us your Identity, Contact, and Financial Data by filling in forms or by corresponding with us by post, phone, email, or otherwise. This includes Personal Data you provide when you:

- Apply for our products or services.
- Create an account on our website.
- Subscribe to our service or publications.
- Request marketing to be sent to you.
- Enter a competition, promotion, or survey; or
- Give us feedback or contact us.

4.1.2. **Automated technologies or interactions.** As you interact with our website, we will automatically collect Technical Data about your equipment, browsing actions, and patterns. We collect this Personal Data by using cookies, server logs, and other similar technologies. We may also receive Technical Data about you if you visit other websites employing our cookies.

4.1.3. **Third parties or publicly available sources.** We will receive Personal Data about you from various third parties and public sources, as set out below:

- Analytics providers (such as Google) based outside the EU.
- Advertising networks based inside the EU.
- Search information providers based inside the EU.
- Contact Data, Financial Data, and Transaction Data from providers of technical, payment, and delivery services.



- Identity Data and Contact Data from data brokers or aggregators based inside the EU.
- Identity Data and Contact Data from publicly available sources (such as Companies House and the Electoral Register) based inside the EU.
- Advertising networks based outside the EU; and
- Search information providers based outside the EU.

All information that the user provides to us is stored on our servers, and Halal Beats will adopt measures to protect your information in accordance

with this policy, including Encrypting data and regular Back-ups.

## 5. THIRD-PARTY LINKS

- 5.1. WWW.HALALBEATS.IO may include links to third-party websites, plug-ins, and applications. Clicking on those links, or enabling those connections, may allow third parties to collect or share data about you.
- 5.2. We do not control these third-party websites and are not responsible for their privacy statements. When you leave our website, we encourage you to read the privacy policy of every website you visit. Browsing and interaction on any other website, including websites which have a link to Halal Beats website, is subject in fact to that website's own terms and policies. Content and links of the mentioned services and third party websites can also change at any time.

## 6. HOW WE USE YOUR PERSONAL DATA

- 6.1. **Halal Beats will only use your Personal Data when the law allows us to. Most commonly, we will use your Personal Data in the following circumstances:**
  - 6.1.1. Where we need to perform the contract we are about to enter into, or have entered into, with you.
  - 6.1.2. Where it is necessary for our legitimate interests (or those of a third party) and your interests and fundamental rights do not override those interests.



6.1.3. Where we need to comply with a legal obligation.

6.1.4. Where it is necessary to process payments and complete purchase orders.

6.1.5. Where it is useful to send periodic emails and marketing surveys.

6.1.6. Where it's useful to personalize user experience on the Halal Beats website;

6.1.7. Where it's useful to understand user navigation on the Halal Beats platform and make improvements to the website;

6.1.8. We will adopt measures to protect user data such as personal information, username, password, financial, payment data, unauthorised access, disclosure, alteration or deletion. Any data exchange between the user and the website relies on an encrypted SSL-secured channel protected thanks to digital signatures. We retain your personal information for all the duration of your Halal Beats account. You have the right to request your information be deleted.

6.2. Where we need to collect Personal Data by law, or under the terms of a contract we have with you, and you fail to provide that data when requested, we may not be able to perform the contract we have or are trying to enter into with you, and as a result, Halal Beats may be unable to provide you with a product or service. In this case, we may have to cancel any product or service you have with us, but we will notify you if this is the case at the time.

6.3. Generally, we do not rely on consent as a legal basis for processing your Personal Data, although we will get your consent before sending third party direct marketing communications to you via email or text message. You have the right to withdraw consent to marketing, at any time, by contacting us.

## **7. PURPOSES FOR WHICH WE WILL USE YOUR PERSONAL DATA**

7.1. Halal Beats has set out below, in a table format, a description of all the ways we plan to use your Personal Data, and which of the legal bases we rely on to do so. We have also identified what our legitimate interests are where appropriate.

7.2. Please note that we may process your Personal Data for more than 1 lawful ground, depending on the specific purpose for which we are using your data. Please contact us if you need details about the specific legal ground we are relying on to process your Personal Data, where more than 1 ground has



been set out in the table below.

## 8. CHANGE OF PURPOSE

8.1. Halal Beats will only use your Personal Data for the purposes for which we



collected it, unless we reasonably consider that we need to use it for another reason, and that reason is compatible with the original purpose. If you wish to get an explanation as to how the processing for the new purpose is compatible with the original purpose, please contact us.

- 8.2. If we need to use your Personal Data for an unrelated purpose, we will notify you and explain the legal basis which allows us to do so.
- 8.3. User acknowledges and agrees that he has the responsibility to review this privacy policy periodically and become aware of modifications.

## 9. DISCLOSURES OF YOUR PERSONAL DATA

- 9.1. For the purposes set out in the table shown in clause 7, Halal Beats may share your Personal Data with any third parties to whom we may choose to sell, transfer, or merge parts of our business or our assets. Alternatively, we may seek to acquire other businesses or merge with them. If a change happens to our business, then the new owners may use your Personal Data in the same way as set out in this Privacy Policy. Also applying with social media to which we can share certain information in order not claiming the user licensed use.
- 9.2. We require all third parties to respect the security of your Personal Data and to treat it in accordance with the law. We do not allow our third-party service providers to use your Personal Data for their own purposes, and only permit them to process your Personal Data for specified purposes and in accordance with our instructions.
- 9.3. We do not transfer your Personal Data outside the European Economic Area (EEA).

## 10. MARKETING AND PROMOTIONAL OFFERS

- 10.1. Halal Beats strive to provide you with choices regarding certain Personal Data uses, particularly around marketing and advertising.
- 10.2. We will get your express **opt-in consent** before we share your Personal Data with any third party for marketing purposes.
- 10.3. We may use your Identity, Contact, Technical, Usage, and Profile Data to form a view on what we think you may want or need, or what may be of interest to you. This is how we decide which products, services, and offers may be relevant for you (we call this marketing).
- 10.4. You will receive marketing communications from Halal Beats if you have



- requested information from us, or purchased goods or services from us, and you have not opted out of receiving that marketing.
- 10.5. You can ask us, or third parties, to stop sending you marketing messages at any time, by logging into the website and checking or unchecking relevant boxes to adjust your marketing preferences, or by contacting us at any time.
- 10.6. Where you opt-out of receiving these marketing messages, this will not apply to Personal Data provided to us as a result of a product/service purchase, warranty registration, product/service experience, or other transactions.

## 11. OUR USE OF COOKIES

11.1. You can set your browser to refuse all, or some, browser cookies, or to alert you when websites set or access cookies. If you disable or refuse cookies, please note that some parts of WWW.HALALBEATS.IO may become inaccessible or not function properly. For more information about the cookies Halal Beats use, please see our Cookies Policy: Support & Faq's page on our website.

### 11.2. **Strictly necessary cookies**

- 11.2.1. These are cookies that are required for the operation of our website. They include, for example, cookies that enable you to log into secure areas of our website, use a shopping cart or make use of e-billing services. They are essential for example to determine the user logging into the Halal Beats account, the process of favoriting a song, creating projects, and purchasing a license, To track user actions during time spent on the site and make improvements, To help to provide website security.

### 11.3. **Analytical/performance cookies**

- 11.3.1. They allow us to recognise and count the number of visitors and to see how visitors move around our website when they are using it. This helps us to improve the way our website works, for example, by ensuring that users are finding what they are looking for easily. They are overly useful to analyze the platform performance and how visitors are using the Halal beats platform. They include page tracking, and geographical origin of visitors too. These cookies may apply when subscribing to Halal Beats newsletters



#### **11.4. Functionality cookies**

- 11.4.1. These are used to recognise you when you return to our website. This enables us to personalise our content for you, greet you by name and remember your preferences (for example, your choice of language or region). They do not track internet usage or collect information to use for selling advertising.

#### **11.5. Targeting cookies**

- 11.5.1. These cookies record your visit to our website, the pages you have visited and the links you have followed. We will use this information to make our website and the advertising displayed on it more relevant to your interests. We may also share this information with third parties for this purpose. These cookies are useful to track user activities on the platform and other sites for the purpose to provide user targeted advertising. Allowing third-party providers to use Cookies for these advertising purposes, including the collection of information across different websites.

### **12. THIRD PARTY COOKIES**

- 12.1. Third-party cookies are cookies set by a website other than the one you are currently on. For example, through a Like button, Facebook can identify visitors and which website they have accessed, by accessing a cookie stored on a visitor's computer. Please note that third parties (including, for example, advertising networks and providers of external services, such as web traffic analysis services), may also use cookies over which we have no control. These cookies are likely to be analytical/performance cookies or targeting cookies.

### **13. YOUR OPTION TO BLOCK COOKIES**

- 13.1. You block cookies by activating the setting on your browser that allows you to refuse the setting of all, or some cookies. However, if you use your browser settings to block all cookies (including essential cookies), you may not be able to access all, or parts of our website.



## **14. DATA SECURITY**

- 14.1. Halal Beats have put in place appropriate security measures to prevent your Personal Data from being accidentally lost, altered, disclosed, or used or accessed in an unauthorised way.
- 14.2. In addition, we limit access to your Personal Data to those employees, agents, contractors, and other third parties who have a business need-to-know. They will only process your Personal Data on our instructions and are subject to a duty of confidentiality.
- 14.3. We have put in place procedures to deal with any suspected Personal Data breach and will notify you, and any applicable regulator, of any breach where we are legally required to do so.

## **15. DATA RETENTION**

- 15.1. Halal Beats will only retain your Personal Data for as long as reasonably necessary to fulfil the purposes we collected it for, including for the purposes of satisfying any legal, regulatory, tax, accounting, or reporting requirements.
- 15.2. We may retain your Personal Data for a longer period in the event of a complaint, or if we reasonably believe there is a prospect of litigation in respect to our relationship with you.
- 15.3. To determine the appropriate retention period for Personal Data, we consider the amount, nature, and sensitivity of the Personal Data; the potential risk of harm from unauthorised use or disclosure of your Personal Data; the purposes for which we process your Personal Data, and whether we can achieve those purposes through other means; and the applicable legal, regulatory, tax, accounting, or other requirements.
- 15.4. By law, we must keep basic information about our customers (including Contact, Identity, Financial, and Transaction Data) for tax purposes, for 6 years after they cease being customers.
- 15.5. In some circumstances, you can ask us to delete your data: see clause 14 below for further information in relation to your legal rights.
- 15.6. In some circumstances, we will anonymise your Personal Data (so that it can no longer be associated with you) for research or statistical purposes. In which case, we may use this information indefinitely without further notice to you.
- 15.7. Personal data will be stored for all the duration of the business customer relationship between you and Halal Beats, meaning having an open account name.



## 16. YOUR LEGAL RIGHTS

16.1. **Under certain circumstances, you have rights under data protection laws in relation to your Personal Data. Specifically, you have the right to:**

2. ***Request access to your Personal Data*** (commonly known as a “data subject access request”). This enables you to receive a copy of the Personal Data we hold about you and to check that we are lawfully processing it.
3. ***Request correction of your Personal Data***. This enables you to have corrected, any incomplete or inaccurate data we hold about you, though we may need to verify the accuracy of the new data you provide to us.
4. ***Request erasure of your Personal Data***. This enables you to ask us to delete or remove any Personal Data where there is no good reason for us continuing to process it. You also have the right to ask us to delete or remove your Personal Data where you have successfully exercised your right to object to processing (see below), where we may have processed your information unlawfully, or where we are required to erase your Personal Data to comply with local law. Please note, that we may not always be able to comply with your request of erasure for specific legal reasons which will be notified to you, if applicable, at the time of your request.
5. ***Object to processing of your Personal Data*** where we are relying on a legitimate interest (or those of a third party), and there is something about your particular situation which makes you want to object to processing on this ground as you feel it impacts on your fundamental rights and freedoms. You also have the right to object where we are processing your Personal Data for direct marketing purposes. In some cases, we may demonstrate that we have compelling legitimate grounds to process your information which override your rights and freedoms. We can object but this does not automatically imply that Halal Beats will need to delete all your personal data.
6. ***Request restriction of processing your Personal Data***. This enables you to ask us to suspend the processing of your Personal Data in the following scenarios:
  - If you want us to establish the data’s accuracy.
  - Where our use of the data is unlawful, but you do not want us to erase it.



- Where you need us to hold the data, even if we no longer require it, as you need it to establish, exercise, or defend legal claims.
  - You have objected to our use of your data, but we need to verify whether we have overriding legitimate grounds to use it.
7. **Request transfer of your Personal Data** to you, or to a third party. We will provide to you, or a third party you have chosen, your Personal Data in a structured, commonly used, machine-readable format. Please note, that this right only applies to automated information which you initially provided consent for us to use, or where we used the information to perform a contract with you. This is called the right to data portability. You can make a portability request at any time.
  8. **Right to withdraw consent** where we are relying on consent to process your Personal Data. However, this will not affect the lawfulness of any processing carried out before you withdraw your consent. If you withdraw your consent, we may not be able to provide certain products or services to you. We will advise you if this is the case, at the time you withdraw your consent. You also have the right to refuse certain uses (such as for marketing purposes), the right to be informed about the collection and use of your personal information.
2. If you wish to exercise any of the rights set out above, please contact us.

## 17. REQUESTING ACCESS TO YOUR PERSONAL DATA

- 17.1. You will not have to pay a fee to access your Personal Data (or to exercise any of the other rights). However, Halal Beats may charge a reasonable fee if your request is clearly unfounded, repetitive, or excessive. Alternatively, we could refuse to comply with your request in these circumstances.
- 17.2. Halal Beats may need to request specific information from you to help us confirm your identity and ensure your right to access your Personal Data (or to exercise any of your other rights). This is a security measure to ensure that Personal Data is not disclosed to any person who has no right to receive it. We may also contact you to ask you for further information in relation to your request to speed up our response.
- 17.3. We try to respond to all legitimate requests within 1 month. Occasionally, it could take us longer than a month if your request is particularly complex or you have made several requests. In this case, we will notify you and keep you updated.



## 18. GLOSSARY

- 18.1. **“Comply with a legal obligation”** means processing your Personal Data where it is necessary for compliance with a legal obligation that we are subject to.
- 18.2. **“Legitimate Interest”** means the interest of our business in conducting and managing our business, to enable us to give you the best service/product, and the best and most secure experience. We make sure we consider and balance any potential impact on you (both positive and negative), and your rights, before we process your Personal Data for our legitimate interests. We do not use your Personal Data for activities where our interests are overridden by the impact on you (unless we have your consent, or are otherwise required or permitted to by law). You can contact us to obtain further information about how we assess our legitimate interests against any potential impact on you in respect of specific activities.
- 18.3. **“Performance of Contract”** means processing your data where it is necessary for the performance of a contract to which you are a party, or to take steps at your request before entering such a contract.
- 18.4. **“Personal Data” or “personal information”** means any information about an individual from which that person can be identified. It does not include data where the identity has been removed (anonymous data).
- 18.5. **“External Third Parties”**
- 18.5.1. Service providers acting as processors based inside the EU, who provide IT and system administration services.
  - 18.5.2. Professional advisers acting as processors or joint controllers, including lawyers, bankers, auditors, and insurers based in the EU, who provide consultancy, banking, legal, insurance, and accounting services.
  - 18.5.3. Regulators and other authorities acting as processors or joint controllers based in the EU, who require reporting of processing activities in certain circumstances.
